Dear Mr. Shackelford:

Thank you for your letter addressed to Bob McGuire and dated May 18, 2015, regarding the Remington-Pratts-Gordonsville transmission project proposed by Virginia Electric and Power Company d/b/a Dominion Virginia Power (the "Company").

As you are aware, the Company initially met with Madison County representatives to discuss this project on March 12, 2015 and sent correspondence to the County soliciting input on March 26, 2015 in accordance with § 15.2-2202 E of the Code of Virginia. In addition to ongoing communications between Company and County representatives, the Company made presentations to the Madison County Board of Supervisors and Planning Commission on March 18, 2015 and May 6, 2015.

The Company solicits feedback from localities on its electric transmission projects, including in accordance with § 15.2-2202 E which states that "[t]he electric utility shall notify the chief administrative officer of every locality in which the electric utility plans to undertake construction of any electric transmission line of 150 kilovolts or more, prior to the filing of any application for approval of such construction with the State Corporation Commission [{"Commission"}], of its intention to file any such application and shall give the locality a reasonable opportunity for consultation about such line." The Company has satisfied the § 15.2-2202 E legal requirement in consulting with the County as described herein.

The Company understands and appreciates the County's feedback and interest in the proposed project. Because the proposed project is designed to address reliability issues arising as early as 2018, the Company cannot delay filing with the Commission for six months as requested by the County.

The comprehensive approval process for an electric transmission project is initiated with the filing of an application for certification and Commission approval. Generally, this application is the first compilation of detailed information about the need for and alternatives to the project currently under consideration, which is prepared in consideration of the public outreach that



occurs in advance of filing. The Commission process will include opportunities for public witness testimony, formal participation as a party and discovery among parties. The Company will build the project that the Commission approves based on its determination that the line is needed and that the route approved will reasonably minimize adverse impacts.
